## Registration

Exhibitors, stand construction companies and freight forwarders must register in advance online, allowing them to easily download and print their own registration confirmation form. You can drive to the specified Check-In with this registration confirmation form. Please follow the signs. The registration information will be scanned in at the Check-In, where they will determine whether a loading zone is available for you. As soon as a loading zone becomes available, you will be given an authori-

sation form allowing your vehicle to enter the exhibition grounds, along with the gate through which you should enter. The direct link to the online registration is: [www.gateway.messefrankfurt.com](http://www.gateway.messefrankfurt.com)  
**Please note:** In case of high volume of traffic waiting times are possible at the Check-In! All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense. [back](#)

## Car parking spaces

We provide parking spaces for a fee for cars with a gross vehicle weight rating of up to 2.5 t. Please use the Shop for Exhibitor Services to make your reservations by no later than four weeks before the start of the event. It may not be possible to honour orders made after this time. We provide parking spaces on the exhibition grounds for car trailers for a fee. These must also be ordered through the Shop for Exhibitor Services by no later than four weeks before the start of the event.

### Truck parking spaces

You may park your vehicle for set-up/dismantling at the Rebstock E1 truck park for a fee for general dismantling activities. Reservations are not required.

**Parking permits will not be sent by e-mail until the ordering deadline has passed.**

## Set-up

### Advanced set-up 19 April

Advanced set-up must be ordered from the Shop for Exhibitor Services. Advanced set-up is free of charge until the ordering deadline. After the deadline the costs are 300 € per stand and day.

Please note that it is not possible to register vehicles until confirmation for advanced setup has been received. [back](#)

### Set-up 20 – 24 April

#### Registration required

Set-up ends 24 April 2023 by 12 p.m.

Please note that the aisles must be clear from 3 p.m. on 24 April. After that, set-up is only possible within the stands.

## Trade fair

### Deliveries during trade fair 25 – 28 April

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. All other vehicles will only be allowed to enter with a valid parking permit.

### Last day of the trade fair 28 April

- Entry will not be permitted after 2 p.m.
- From 2 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds
- Please head to the assembly point at the Rebstock car park. This is the only place where you can obtain a dismantling vehicle pass.

### Admission for special dismantling vehicles

#### 28 April, 4 p.m. – 6 p.m.

for exhibitors, for the transport of smaller loads by cars and vans up to 3.5 t gross vehicle weight rating. Pre-ordering is not possible, but a max. of 400 of these special permits are issued. Therefore, you should take care of it early: 23 – 28.4.2023, 10 a.m. to 2 p.m. at the Central Information Desk on Level 02 of the Torhaus.

- Presentation of a customer number
- Presentation of the exhibitor pass
- Signing a declaration that you will be charged an additional €200.00 when invoiced for your ancillary costs if you leave the exhibition grounds after 7 p.m.

**Please note that you will not be able to use the goods lifts.**

## Dismantling

### General admission for dismantling vehicles

#### 28 April after 7 p.m.

Please drive your dismantling vehicles straight to the designated dismantling assembly point at the Rebstock car park. This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 7 p.m.

Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls.
