## Registration

Exhibitors, stand construction companies and freight forwarders must register in advance online, allowing them to easily download and print their own registration confirmation form. You can drive to the specified Check-In with this registration confirmation form. Please follow the signs. The registration information will be scanned in at the Check-In, where they will determine whether a loading zone is available for you. As soon as a loading zone becomes available, you will be given an authori-

sation form allowing your vehicle to enter the exhibition grounds, along with the gate through which you should enter.

Please note: In case of high volume of traffic waiting times are possible at the Check-In! All vehicles must depart the exhibition grounds as soon as they have been unloaded/loaded. Vehicles that stay longer than permitted may be towed away at the owner's expense, back

## **Car parking spaces**

We provide parking spaces for a fee for cars with a gross vehicle weight rating of up to 2.5 t. Please use the Shop for Exhibitor Services to make your reservations by no later than four weeks before the start of the event. It may not be possible to honour orders made after this time. We provide parking spaces on the exhibition grounds for car trailers for a fee. These must also be ordered through the Shop for Exhibitor Services by no later than four weeks before the start of the event.

#### Truck parking spaces

You may park your vehicle for set-up/dismantling at the Rebstock E1 truck park for a fee for general dismantling activities. Reservations are not requi-

#### Set-up

#### **Set-up** 15.3 – 18.3 Registration required

Please note that cars and transporters up to 3.5 t are only allowed on the parking decks of halls 9 (P9) und 12 (P12) during set-up and dismantling period.

For a deposit of € 100 in cash, you can also drive for 1 hour directly to the loading zones of the exhibition halls.

Set-up ends 18.3.2024 by 12 p.m.

Please note that the aisles must be clear from 3 p.m. on 18. March 2024. After that, set-up is only possible within the stands. back

#### Trade fair

#### Deliveries during trade fair 19. - 21.3.2024

For deliveries, vehicles will be granted entry via the gate closest to the exhibition hall for one hour in return for a deposit of €100.00. All other vehicles will only be allowed to enter with a valid parking

#### Last day of the trade fair 22.3.2024

- Entry will not be permitted after 2 p.m.
- From 2 p.m. until the start of admission for dismantling vehicles, no vehicles will be allowed to enter the exhibition grounds
- Please head to the assembly point at the Rebstock car park. This is the only place where you can obtain a dismantling vehicle pass.

#### Admission for special dismantling vehicles 22.3.2024 4 p.m. – 6 p.m.

With this permit you can transport smaller loads with a vehicle < 3.5 t GVW out of the fair grounds. Only exhibitors can obtain this permit in person at the Central Information Desk in the Torhaus. Level 02 from 18.3 - 21.3 from 10 am - 1 pm and on 22.3 from 10 am - 1 pm. It is not possible to order in advance.

At the counter you must

- indicate and prove your exhibitor number
- present your valid exhibitor pass
- sign a cost absorption declaration for EUR 200 (settlement will be made with the ancillary costs statement if you leave the exhibition grounds after 6 p.m.).

Please note that you will not be able to use the goods lifts.

# **Dismantling**

Please note: At 22.3. from 4 p.m. – 7 p.m. dismantling is only inside the stands possible, due to carpet removal in the aisles and delivery of empties by the freight forwarders.

#### **General admission for dismantling vehicles** 22.3.2024 after 7 p.m.

Please drive your dismantling vehicles straight to the designated dismantling assembly point at the Rebstock car park. This is the only place you can receive your dismantling vehicle pass to enter the exhibition grounds, and it is the only place where police will permit and direct entry starting after 7 p.m

Access from other streets will not be granted until all of the vehicles from this area have already entered the exhibition grounds. It is only after this has occurred that cars from the car parks on the exhibition grounds will also be permitted to drive to the halls.

Please note: Registration is not possible for the last day of the fair and the dismantling entrance.
